Old Business:

Work Returned by Mike:

36 Willow (Q1) - requesting prune of Borough trees on adjacent PAL Field property & inspection of trees for health.

Corner of Lake St/Woodbine St (Q4) - requesting removal of tree near stop sign.

Work Returned by Joe:

55 Maiden Q3) - requesting tree to be inspected for safety, branch has fallen in past & now roots look crumbly.

15 Regent (Q4) - states 2 Borough trees are dead, requesting removal.

Work Returned by Steve:

140 New Jersey (Q1) - removal request.

125 Baker (Q4) - requests another tree to be inspected for health, states it looks sick.

Work Returned by Phil/DPW:

- **40 Armour (Q2)** would like to remove 2 trees, wants to confirm if they are private or Borough, emailed land survey to DPW on 4/28/21.
- 29 Moos (Q2) requesting removal of other 3 trees on Marchbank Property behind his property.
- **49 Moos** (**Q2**) wants trees removed behind her property by the brook, afraid they might fall into the water & onto her property.
- 31 Wilbur (Q3) requesting root pruning during sidewalk repair, states one tree looks dead.
- **122 E. Church (Q1)** resident states DPW left stalk, asks if DPW will repair sidewalk. <u>DPW removed</u> trunk on 6/1/21.

Marchbank Property/Museum/Cooper's Pond (Q2) - DPW replanted 31 trees.

- **1 Marcotte** (Q3) requesting removal of other tree, first tree approved August 2020 for removal. <u>DPW removed both trees on 5/24/21.</u>
- 111 Graphic (O2) tree drops branches, hollow, on N. Vivyen St. DPW removed on 6/2/21.

Vivyen Field (Q2) - <u>DPW removed 4 trees between Vivyen Field & swim club, crown-raised 2 Oaks along field fence on 5/5/21.</u>

30 Beechwood (Q3) - resident wants to know if tree on E. Englewood Ave behind utility pole outside of fence is Borough tree or private tree. <u>Private tree.</u>

New Business:

- **22 Fahrner** (Q1) removal request, drops limbs in wind, roots causing damage.
- **42 Beucler (Q3)** holes in tree, drops limbs, requesting inspection for safety.
- **60 Levitt** (**Q4**) neighbor at #54 Levitt states branches from tree at #60 Levitt fall onto his driveway, requesting inspection of tree.
- 139 Highgate (Q4) removal request, sidewalk lift.
