Councilperson Lodato called the meeting to order at 8:00 p.m. with the reading of the Open Public Meetings Act Statement, "In compliance with the Open Public Meetings Act, the notice requirements have been satisfied. Meeting dates for the year are confirmed at the Annual Meeting. The Annual Notice is sent to the Record, Star Ledger, Twin Boro News, and Cablevision, placed on two Municipal Bulletin Boards and is on file in the Office of the Borough Clerk."

CAPITAL IMPROVEMENTS/BOROUGH ENGINEER

A. Engineering & Inspection Status Report

Robert Klein of Remington & Vernick Engineers, Borough Engineer, stated the road program is ongoing. Phase I is complete and Phase II is ongoing. Mr. Klein stated they are finishing up concrete work on New York Avenue and will then move onto Orchard Street and Railroad Avenue. The same contractor will move onto the NJDOT funded roads, which are Bedford Avenue and Belford Avenue. Mr. Klein stated he was not aware of the issue on Sergeant Court. The cracked curb and other issues will be taken care of.

Borough Administrator Gallo inquired about the puddling and cracked curb on Sergeant Court. There have been a lot of calls from residents and our team needs to make sure to stay on top of it.

Council President Rivera inquired when will the last street to be done will be finished.

Mr. Klein stated the contractor has until around Thanksgiving and will ensure the contractor remains on schedule.

Mr. Gallo pointed out the height of the dais has changed and currently going through the punch list items.

stated at the Board of Health meeting on September 10th they discussed updates on the West Nile Virus and COVID-19. There will be a Flu Shot Clinic on October 8th, 2024 from 2-4pm. Kayla Williams reported two violations, as businesses were caught selling of tobacco to minors. The Board will conduct a blood drive soon.

stated on September 27th, 2024, the Planning Board met and approved a two-lot subdivision for the construction of two new single family houses. The proposal was compliant with borough ordinances. The Master Plan Reexamination Report was reviewed by the Board and recommendation to adopt it was made to the governing body. The Fire Department has several items not purchased yet as they are waiting for quotes from the vendors. The Bergenfield High School Class of 1974 celebrated their 50th year reunion on September 20th, 2024. He was part of that class. It was great to see everyone.

stated the recreation department is preparing for Halloween. There will be a costume parade on October 26th in the morning at Cooper's Pond. They will have the Haunted Walk open for those people that don't want to be scared. The Trunk or Treat will be October 31st on Washington Avenue. Hanukkah Menorah Lighting is scheduled for December 7th, 2024 with a rain date on December 8th, 2024. All summer sports have been completed. Fall sports are in full swing. The BVAC has gone on 1,590 calls year to date. The average response time is 3 minutes and 22 seconds.

PUBLIC COMMENTS

Cristino Vilorio, resident, stated he had requested a traffic study be done for the home next to his and thanked the Mayor, Council, and police for getting it done. He expressed concern regarding the variance application for 16 Glenwood Drive North, and stated if it approved, it will create obstructions of about 210 feet. He has lived in the neighborhood for over 20 years and feels it will create unsafe conditions. He requested the liaison assigned to the Zoning Board share the information from the traffic study.

Mary Sullivan, resident, stated Mr. Vilorio didn't mention that the property is a curbed street lot, which is a bigger problem. She inquired when the PAL field will be ready to be used. Ms. Sullivan inquired if the revaluation will be done this year.

Mr. Gallo stated the PAL field is currently being used. It takes time to upgrade the fences, the clay, and other work that needs to be done. He didn't have an answer regarding the revaluation.

John Smith, resident, stated the Zoning Board of Adjustment meeting in October has been cancelled. Mr. Smith stated the members tried to explain to the residents that the Council has no control over the Zoning Board. He and the Chairman requested a traffic study planner to represent the Zoning Board, which the application would have to for. Mr. Smith stated it will show the residents that the Zoning Board members represent all.

Thomas "Tom" Morrell, resident and PAL Basketball coach, stated they are struggling to get access to the gyms at the schools and have a decent group of kids playing basketball.

Mr. Gallo inquired if he's been in contact with Ed Volmer.

Councilperson Kornbluth stated she will follow up with Ed Volmer.

Mr. Morrell stated the prices for the recreation program from 3rd to 8th grade have not changed from last year. The program has made changes this year by getting jerseys for the kids and the referees

need to be paid for the games. The soccer program in 2016 was \$75 and now it is \$160. He explained that due to the lack of volunteers, they took over the program and hired a third party for training twice a week for eight weeks for the first and second graders. David Vega from Hoops Vision does the training at a discounted rate of \$12.50 an hour. The program is exploring sponsorships and reaching out to local businesses.

Mr. Gallo inquired who is doing the training. He stated it's important to remain transparent and asked if Mr. Morrelll has reached out to Ed Volmer. Mr. Gallo stated he received several complaints about pricing. He remembers Ed did research and found the prices from other towns to be higher. There needs to be further discussion on how they can strengthen the program. The governing body doesn't want to see a substandard program and would have liked to hear from Mr. Morrell six months ago when the program was taken over. Mr. Gallo requested he reach out to Ed Volmer to set up a meeting.

George Mendoza, resident and PAL Basketball coach, stated they are unable to get coaches for the fall. Residents are looking for gyms to rent.

Mr. Gallo stated the borough and the Board of Education are separate, but can work together. He stated he will call Dr. Tully to see what can be done, but doesn't know if there are any NJISSA rules regarding the high school.

Mayor Amatorio suggested providing the proposed schedule, so the borough can look into what facilities are available.

Motion by Councilperson Pascual, second by Councilperson Kornbluth to close Public Comments. All present voting in favor, none opposed.
