ORDINANCE 19-2540 – AN ORDINANCE AMENDING CHAPTER 42 OF THE CODE OF THE BOROUGH OF BERGENFIELD, ENTITLED “LENGTH OF SERVICE AWARDS PROGRAM

was introduced at a Work Session meeting of the Mayor and Council of the Borough of Bergenfield, in the County of Bergen, New Jersey, held on Tuesday, February 5, 2019, and will be further considered for final passage after public hearing at a meeting of the Mayor and Council to be held in the Executive Council Chambers, Bergenfield Municipal Center, 198 North Washington Avenue, Bergenfield, New Jersey on Tuesday, February 19, 2019 at 8:00 p.m. prevailing time, or as soon thereafter as the matter can be heard.

A clear and concise statement for this ordinance is to amend the entitled service requirements for the Volunteer Ambulance Corps. to qualify for the length of service awards program, as set forth in the ordinance.

**AN ORDINANCE AMENDING CHAPTER 42 OF THE CODE OF THE BOROUGH OF BERGENFIELD,
ENTITLED "LENGTH OF SERVICE AWARDS PROGRAM"**

WHEREAS, Chapter 42 of the Code of the Borough of Bergenfield sets forth all regulations regarding Length of Service Awards Program in the Borough of Bergenfield; and,

BE IT ORDAINED, by the Mayor and Council of the Borough of Bergenfield, County of Bergen and State of New Jersey that those portions of the aforesaid set forth below are hereby amended as follows and that those portions of the Ordinance not set forth below shall remain unchanged.

Chapter 42. Length of Service Awards Program

42.5 entitled Service Requirements.

Schedule B-Bergenfield Volunteer Ambulance Corps. Inc.

1. Ambulance calls - .25 points for 1 hour of duty shift time; 5 points for 1 general call
2. Drills (Captain's Classes) - 2 points per class or drill. Any Captain's class held that offers CEU's-2 points to be awarded for Captain's Class; 1 point per CEU
3. Training – 1 point per hour for EMT CEU classes
5. Meetings – 2 points per meeting.
6. Miscellaneous Activities – Each special standby/event shall be awarded 3 points

Severability All provisions of this Ordinance are severable. If for any reason, any provision of this Ordinance is held to be invalid, the validity of the remainder of the Ordinance shall not be affected.

Effective Date. This Ordinance shall become effective upon final approval and publication, pursuant to law, and upon completion of all outstanding cases.

NOTICE IS HEREBY GIVEN that the foregoing Ordinance was introduced at a meeting of the Borough of Bergenfield on the 5th day of February, 2019 and passed on first reading, and the same was ordered for final passage at a meeting of the Council to be held at the Municipal Building in the Borough of Bergenfield, Bergen County, New Jersey, on the 19th day of February, 2019 at 8 p.m., at which time and place all persons interested will be given an opportunity to be heard concerning such Ordinance.
